

Role of the public sector in responding to the global energy crisis

Event background

The Public Sector plays a vital role in achieving clean energy transitions, both acting as a leading example of energy consumption reduction and incentivising broader investments in energy efficiency activities. This special event will act to highlight national and local government actions for driving energy efficiency in key public sectors focusing on public buildings, and coordination of actions at these levels of government. Opportunities for the public sector to respond to current global challenges will form a core theme of this event, aiming to foster a dialogue on short and medium-term solutions. Key discussion topics will include:

- the public sector in the role of the first mover
- enabling innovation and leadership in the public sector
- the importance of following the policy package approach
- successful options for scalability, from first mover to widespread delivery with a focus on the coordination of actions required for delivery.

The aim will be to demonstrate what has been done, what can be done, and how to build on successes to increase ambition.

Based on IEA analysis of best practice, and the work of the Global Commission for Urgent Action on Energy Efficiency, ten strategic principles were developed to help guide policy makers to enhance and expand their energy efficiency policies and programmes, and to quickly accelerate energy efficiency gains through new and stronger policy actions. This special event feeds into three of these principles: strategic principle 6 - The public sector should lead by example; strategic principle 7 - Engage all parts of society; and strategic principle 8 - Leverage behavioural insights for more effective policy.
