

# Kardex gains global visibility and smarter control with Rydoo Smart Audit

Spending hours reviewing expenses manually is a challenge global companies often face, especially when their team travels around the world.

Tediously translating receipts from Korea or Finland manually is a must to check them against company policy. Still, it can lead to out-of-policy claims slipping by unnoticed.

This used to be Kardex's reality. The global intralogistics leader is undergoing a company-wide digital transformation, including implementing SAP S/4HANA.

As part of the digitalisation process, the team quickly understood expense management as an area needing stronger oversight. As an international infrastructure with multiple branches, each with specific compliance standards, enforcing policies consistently quickly became a challenge.

Kardex needed a smarter way to gain control and global visibility of employee spending.

The solution? Bring AI into the mix.

## The challenge: decentralised policies and reactive audits

Expense reviews at Kardex relied heavily on random sampling. Teams had to interpret and enforce policies across diverse local frameworks, from different per diem allowances to tipping customs.

Although the group-level policy was clearly communicated, enforcing it consistently across multiple jurisdictions remained challenging.

The sheer volume of exceptions and local nuances meant some errors, misinterpretations, or non-compliant claims could have gone unnoticed due to the limits of a manual process stretched across multiple jurisdictions.

## Introducing AI-powered expense auditing with Rydoo Smart Audit

Kardex turned to Rydoo Smart Audit for a low-effort, high-impact solution, allowing the team to shift from reactive sampling to proactive control.

The system uses AI to automatically analyse every expense, detecting and flagging out-of-policy items — from incorrect claims and duplicates to prohibited purchases — in near real-time.

The turning-point feature? Instant translation of receipts.

- Automatically translated receipts for faster, more accurate manager approvals;
- Real-time alerts when alcohol spending exceeds policy threshold;
- Early detection of duplicates and mismatches with the receipt information;
- Simplifies submitting, approving and controlling expenses, making the process easier for the whole team.

Kardex adopted a phased, test-and-learn approach. Initially, the team enabled specific policy checks in selected branches. Once validated, they expanded globally. The ease of deployment required no developer involvement, accelerating adoption.
