OECD Country Programme for Ukraine – Outline

Objectives:

To support **Ukraine's reform, recovery, and reconstruction** efforts.

Expected outcomes:

Stronger institutions, improved governance and better economic outcomes to reactivate the economy and attract greater investment for a sustainable recovery.

Priority activities aligned with:

- Draft National Recovery and Development Plan of Ukraine
- Government of Ukraine's Priority Action Plan for 2023
- Ukraine Plan 2024-2027
- Multi-Agency Donor Co-ordination Platform priorities

Timeline: 4 years, from 7 June 2023 to 6 June 2027

Expertise: Whole-of-OECD approach involving 13 expert Directorates

serving dedicated OECD bodies, custodians of OECD

instruments.

Budget: EUR 16.5 million (at hand: EUR 9.9M from 16 donors)



The Country Programme for Ukraine, prepared by the OECD in close consultations with the Government of Ukraine, launched at the OECD Ministerial Council Meeting by OECD Secretary-General, Prime Minister of Ukraine and the UK Foreign Secretary on 7 June 2023.
