


United Kingdom



Ms. Thérèse Coffey

Secretary of State for Work and Pensions

The Rt Hon Thérèse Coffey was appointed Secretary of State at the Department for Work and Pensions on 8 September 2019. Thérèse was previously Minister of State at the Department for Environment, Food and Rural Affairs between 25 July 2019 and 8 September 2019. She was previously Parliamentary Under Secretary of State at the Department for Environment, Food and Rural Affairs from 17 July 2016 to 25 July 2019. She was elected the Conservative MP for Suffolk Coastal in May 2010. Thérèse graduated from University College London (UCL) with a PhD in chemistry. Thérèse Coffey served as Deputy Leader of the House of Commons from May 2015 until July 2016. Thérèse served on the Culture, Media and Sport Committee until she was appointed Parliamentary Private Secretary to Michael Fallon, Minister for Business and Energy. Thérèse has campaigned on stopping the A14 toll, improving NHS experience for patients and better broadband. Thérèse worked for the international company Mars. When Thérèse qualified as a chartered management accountant, she became Finance Director for a UK subsidiary of Mars. She has also worked at the BBC. Thérèse enjoys watching football, gardening and music, especially Muse. She is a CAMRA (Campaign for Real Ale) member.

Australia



Mr. Brendan Pearson

Permanent Representative of Australia to the OECD

Brendan Pearson has been Australian Ambassador and Permanent Representative to the OECD since October 2021. From June 2019 to September 2021 he served as Senior Adviser (International – Trade and Investment) to the Prime Minister of Australia, Scott Morrison MP and earlier Senior Adviser to then Minister for Finance, Senator Mathias Cormann. Brendan has more than three decades' experience in diplomacy, trade negotiations media and business representation in Australia, East Asia and the United States. This includes more than 9 years in senior roles at the Minerals Council of Australia, including 4 years as the chief executive. Brendan also served as an Australian diplomat in Washington DC, as Lead Negotiator on Services in the Doha Round and as the North Asia correspondent for the Australian Financial Review based in Tokyo. Brendan has also served as a Visiting Scholar at the Department of Politics and International Studies at the University of Cambridge. Brendan has a Bachelor of Arts (Honours) degree from the Australian National University and a Master of Philosophy in International Relations from the University of Cambridge.

Mr. Pierre-Yves Dermagne

Vice-Premier Minister and Minister for the Economy and Labour

Pierre-Yves Dermagne (born December 30, 1980 in Namur) is a member of the Belgian Socialist Party (PS). He holds a law degree (Catholic University of Louvain) and is a lawyer. He was elected Member of Parliament for Wallonia and the French Community for the first time on 25 May 2014. He served as Walloon regional minister as of 2017. After the regional elections in 2019, he was reelected Member of Parliament for Wallonia and the French Community, and he became Walloon Minister for Housing and Local Authorities. On October 1, 2020, he became Belgian Deputy Prime Minister and Minister for the Economy and Labour in the De Croo government. He is also Mayor of the municipality of Rochefort since the municipal elections of 2018.

Ms. Signe Riisalo

Minister of Social Protection

Signe Riisalo is the Minister of Social Protection of the Republic of Estonia from 26 January 2021. She is a member of the Estonian Reform Party since 1994.

Signe Riisalo was born on 8 October 1968 in Tallinn. She is a mother of a son and a daughter.

Ms. Luisa María Alcalde Luján

Minister of Labor and Social Welfare

She was born in Mexico City on 24 August 1987 and has a Law degree from the National Autonomous University of Mexico (UNAM), 2006-2011 and a Master's degree in Public Policies and Labor Law at the University of Berkeley, California. Ms. Alcalde Luján was the Representative of young people and students in the Movement of National Regeneration Party (MORENA), 2011 and she was Congresswoman for the Citizen Movement Party, where she chaired the Labor and Social Welfare Committee, 2012-2015.



Spain



Mr. José Luis Escrivá

Minister of Inclusion, Social Security and Migration

José Luis Escrivá is the Spanish Minister of Inclusion, Social Security and Migrations since January 2020. He started his career as an economist at the Bank of Spain, where he held various positions in the Research Department, and later in Europe, where he actively participated in the process of monetary integration as an adviser to the European Monetary Institute since 1993. With the start of the Monetary Union in 1999 he became Head of the Monetary Policy Division of the European Central Bank. Between 2004 and 2012 he worked at the BBVA banking group, first as its global Chief-Economist and Director of the Research Department, and from 2010 as the Managing Director responsible for Global Public Finance. Between 2012 and 2014 he became the Chief Representative for the Americas at the Basel-based Bank for International Settlements. In March 2014 he became the first President of the newly created Spanish Agency for Fiscal Responsibility (AIREF). During his mandate, he also served as Chair of the EU Network of Independent Fiscal Institutions.

Austria



Mr. Martin G. Kocher

Federal Minister for Labour and Federal Minister for Digital and Economic Affairs

After studying economics at the University of Innsbruck, initially a research and teaching assistant at the Institute of Public Finance and Center for Experimental Economics, Martin Kocher started an international career with posts at universities in East Anglia, Munich, Brisbane and Gothenburg. From 2016 to 2021, Martin Kocher was Director of the Institute for Advanced Studies (IHS) in Vienna and from 2018 to 2021, Head of the Competence Center for Behavioral Economics Insight Austria. From 2020 to 2021, Martin Kocher was Chairman of the Statistics Council, Member of the Austrian Financial Market Stability Board and President of the Austrian Fiscal Advisory Council. Martin Kocher had been Federal Minister for Labour since 1 February 2021. On 11 May 2022, Martin Kocher was sworn in as Federal Minister for Labour and Federal Minister for Digital and Economic Affairs.

Brazil



Mr. José Carlos Oliveira

Minister of Labour and Social Security

José Carlos Oliveira was born on October 25th, 1965. He has spent his whole life in São Paulo, where he has also studied and worked since a very early age. He holds a bachelor degree in Business Administration from Alvares Penteado Trade School Foundation. He joined the Brazilian Public Administration in 1985 as a civil servant from the National Social Security Institute – INSS. While in INSS, he was the head of the São Paulo unit until 2003, when he requested a formal license. He was elected a city councillor in São Paulo for the 2008-2012 term. During his license period, he also worked as a businessman in the construction industry. In 2016 he resumed his career in INSS as the Supervisor for the Southeast region and, later on, the Director for Benefits. In November 2021, he has been appointed the President of INSS. Since March 2022, Mr. Oliveira has been the Brazilian Minister responsible for labour, employment and social security. With almost 40 years of expertise in this realm, he has underlined 3 priorities for his tenure: (i) valuing personnel; (ii) restructuring in-person, careful social security assistance and (iii) digital transformation in the labour market.

Mr. Jean-François Tremblay

Sous-Ministre de l'Emploi et Développement Social

Jean-François Tremblay s'est joint à EDSC à titre de sous-ministre en janvier 2022.

Avant cette nomination, M. Tremblay a été sous-ministre des Ressources naturelles de 2020 à 2022, sous-ministre des Services aux Autochtones de 2017 à 2020, sous-ministre de l'Infrastructure et des Collectivités de 2016 à 2017 et sous-ministre des Transports, de l'Infrastructure et des Collectivités (TIC) de 2015 à 2016. Avant de se joindre au portefeuille des TIC, M. Tremblay était sous-secrétaire du Cabinet (Opérations) au sein du Bureau du Conseil privé depuis avril 2013. M. Tremblay a été au ministère des Affaires autochtones et du Développement du Nord Canada où il a occupé le poste de sous-ministre adjoint principal, Traités et gouvernement autochtone (2012 à 2013) et de sous-ministre adjoint principal, Politiques et orientation stratégique (2010 à 2012). Il a travaillé pour le Bureau du Conseil privé à titre de secrétaire adjoint du Cabinet Priorités et planification (2007 à 2010) ainsi que de sous-ministre adjoint, Opérations gouvernementales (2006 et 2007). Deputy Minister of Employment and Social Development

Jean-François Tremblay joined ESDC as Deputy Minister in January 2022. Prior to this appointment, Mr. Tremblay served as the Deputy Minister of Natural Resources Canada from 2020 to 2022, the Deputy Minister of Indigenous Services from 2017 to 2020, the Deputy Minister for Infrastructure and Communities from 2016 to 2017 and the Deputy Minister of Transport, Infrastructure and Communities (TIC) from 2015 to 2016. Before joining the TIC portfolio, he was Deputy Secretary to the Cabinet Operations, Privy Council Office, since April 2013. Mr. Tremblay spent time at Aboriginal Affairs and Northern Development Canada, where he held the positions of Senior Assistant Deputy Minister, Treaties and Aboriginal Government (2012 to 2013) and Senior Assistant Deputy Minister, Policy and Strategic Direction (2010 to 2012). He also worked with the Privy Council Office, serving as Assistant Secretary to the Cabinet, Priorities and Planning (2007 to 2010) and Assistant Deputy Minister in Intergovernmental Operations (2006 and 2007). Mr. Tremblay joined the federal public service in 2000 as a policy analyst with the Privy Council Office. He holds a Ph.D. in Political Science from Université Laval.

Ms. Jeannette Jara Román

Minister of Labour and Social Security

Jeannette Jara Román is Minister of Labour and Social Security of Chile since March 2022. Previously, between 2016 and 2018, she was Undersecretary of Social Security and before that, she was Head of Cabinet of the Minister of Social Development. Besides, she has worked as a university professor teaching the chairs of Theory of Government, Constitutional Law, Public Administration and Tax Law. Minister Jara is a Public Administrator and Lawyer from the University of Santiago (Usach) and the Central University, respectively. Currently, she is Master candidate in Public Management at Usach. She has had an outstanding career as a student and social leader. She was president of the Federation of Students of the University of Santiago (Feusach) and, later, when she worked as a public administrator in the Internal Revenue Service, she was a union leader of the Association of Auditors of the SII (AFIICH), where she held various charges.

Colombia



Mr. Ángel Custodio Cabrera Báez

Minister of Labor

The Minister of Labour, is a Professional in Public Accounting, graduated with honors from the National University of Colombia (UNAL), with specialization in Finance and Tax Law from the Universidad de los Andes. One of his greatest recognitions is the title of Emeritus Graduate of the National University for being the author of the Law of Resources for the UNAL University Hospital and public education in Colombia. He served as Director for Colombia before the Central American Bank for Economic Integration, where he demonstrated his experience and capacity in the formulation and implementation of development projects. Thanks to his extensive experience and knowledge in tax and financial matters, he has worked as a tax and financial advisor in different economic sectors. On the other hand, he was elected Senator of the Republic for one term and Representative to the House for two terms, where he chaired the third commission, which is responsible for all economic and budgetary aspects of the nation. Similarly, during this time he stood out for his legislative work, where he was the author and co-author of different norms of high social impact in favour of some of the most vulnerable groups in Colombia.



Costa Rica



Mr. Alejandro Patiño Cruz

Deputy Permanent Delegate of Costa-Rica to the OECD

He currently serves as Deputy Permanent Representative of Costa Rica before the OECD. Previously, he served as Head of Trade of the Mission of Costa Rica to the European Union in Brussels, Belgium. Beforehand, he was stationed in San José, Costa Rica as adviser to the Ministry of Foreign Trade on OECD matters and on Investor-State dispute settlement. Likewise, he served as representative for Central America of the Japan Trade Promotion Agency (JETRO) and legal and political advisor to the Embassy of Japan in Costa Rica. He obtained with honors his Master of Law (LLM) in International Trade Law and Public Policy (IELPO) at the University of Barcelona, and he has Master degree cum laude in European Union Law from Royal Institute of European Studies of Zaragoza. Furthermore, he has a degree in Law from the Universidad Escuela Libre de Derecho of Costa Rica and a degree in international Relations from the Universidad Latina of Costa Rica. Croatia



Mr. Marin Piletić

Minister of Labour, Pension System, Family and Social Policy

Marin Piletić was born on 12 January 1983, in the city of Novska. After finishing primary and high school education in his hometown, he completed his higher education at The Faculty of Humanities and Social Sciences in Zagreb where he obtained his university degree in Croatian language and literature and History. He first started working as a teacher of Croatian language in primary schools in Novska and Lipik. In 2009 Croatian local elections he was elected Deputy Mayor of Novska, a position he held until year 2013. Next year he was elected Deputy County Prefect for Sisak-Moslavina County and worked in Sisak until 2017, when he ran as candidate and was elected Mayor of Novska, winning the majority of votes in the first round of elections. He was re-elected Mayor in 2021 local elections before becoming a member of the Croatian Parliament in June 2021, replacing Ivan Celjak who won county elections for Sisak-Moslavina County Prefect. In April 2022 he was appointed Minister of Labour, Pension System, Family and Social Policy. He is married and father of two children.



Czech Republic



Ms. Kateřina Štěpánková

Deputy Minister of Section for Employment, Ministry of Labour and Social Affairs

Kateřina Štěpánková joined the Ministry of Labour and Social Affairs as the Head of the Foreign Employment Unit, she gradually became the Director of the Employment and Vocation Department and since December 2019, she has held the position of Deputy Minister of Section for Employment. Kateřina Štěpánková deals with the employment area in the whole complex of this agenda, i.e. conceptual and strategic tasks in relation to the labour market, implementation of active employment policy including retraining, labour migration and employment of foreigners, implementation of systemic projects in the field of employment, which are financed by the European Social Fund. She also deals with topics such as social entrepreneurship, labour market forecasting or retraining system. Prior to joining the Ministry of Labour and Social Affairs, she worked for a number of years in academia (Charles University, Academy of Arts, Architecture and Design in Prague), where, in addition to teaching, she also held management positions, particularly in the field of foreign relations and student affairs.

Mr. Carsten Staur

Permanent Representative of Denmark to the OECD

H.E Ambassador Carsten Staur took up his duties as Permanent Representative of Denmark to the OECD in Paris in 2018. He holds a degree in History and Literature from the University of Copenhagen (1980). He then became Denmark's Ambassador to Israel (1996-1998). Mr. Staur was State Secretary in the Ministry of Foreign Affairs in charge of Denmark's development cooperation (Danida) from 2001 to 2007. Carsten Staur has chaired the Board of UNDP, UNFPA, and UNOPS (2007-2008), the drafting Committee of the 32nd International Red Cross and Red Crescent Conference (2015) and UNHCR's Executive Committee (2015-2016). Prior to taking up his duties as Ambassador to the OECD, Mr. Staur was Denmark's Permanent Representative to the United Nations in Geneva (2013-2018), and prior to this Permanent Representative to the United Nations in New York (2007-2013). He has served as member of the Board of the Global Fund to Fight AIDS, Tuberculosis and Malaria (GFATM) from 2005 to 2007 and again from 2015 to 2017, and as Vice-Chair of the Council of the International Organization for Migration (IOM) from 2016 to 2018. In 2013, he published a book on the UN: "Shared Responsibility. The United Nations in the Age of Globalization", McGill-Queens's University Press.

Ms. Tuula Haatainen

Minister of Employment

Tuula Haatainen is Finland's Minister of Employment, a long-term parliamentarian and a former municipal director. As a member of the Government, she has served not only the Government of Sanna Marin but also the Governments of Anneli Jäätteenmäki and Matti Vanhanen, serving first as Minister of Education between 2003 and 2005 and later as Minister of Social Affairs and Health between 2005 and 2007. Minister Haatainen has a master's degree in political science and she is a qualified nurse. During her career, she has had numerous governmental, international and NGO confidence activities. She is married and has two adult children.

Greece



Mr. Kostis Hatzidakis

Minister of Labour and Social Affairs

He is a member of the Greek Parliament and Vice President of the New Democracy Party. He was born in Rethymno, Crete, in 1965. He is a member of the Greek Parliament since 2007. He is a lawyer in Athens. He was the President of the Youth Organization of New Democracy (1992-1994). He was a Member of the European Parliament (1994-2007). He was the Minister in the following ministries: Transport (2007-2009), Development (2012-2014) and Environment and Energy (2019 – 05.01.2021).

Hungary



Mr. László Turóczy

Ambassador, Permanent Representative of Hungary to OECD and UNESCO

Mr. Turóczy was born in Budapest/Hungary in 1978 and earned his MSc degree in Economics at the Faculty of Economics of the Budapest University of Economic Sciences and Public Administration in 2002. He joined Hungary's Ministry of Economic Affairs in 2001, where he first served as a macro-economic analyst, and subsequently as head of unit and deputy head of the ministry's Economics Department. Mr. Guðmundur Ingi Guðbrandsson

Minister of Social Affairs and the Labour Market

Guðmundur Ingi Guðbrandsson took office as Minister of Social Affairs and the Labour Market on November 28th 2021 for the Left-Green Party. He was Minister for the Environment and Natural Resources from November 30, 2017 to November 28, 2021. Guðmundur Ingi was born on March 28 1977. He holds a BSc degree in Biology from the University of Iceland and a masters degree in Environmental Management from Yale University. He was the CEO at Landvernd – Icelandic Environment Association from 2011 – 2017. He also worked for the University of Iceland carrying out research in ecology and environmental sciences, and for the Soil Conservation Service of Iceland in the fields of global studies and research. Since 2006, Guðmundur Ingi has been a guest lecturer at the University of Iceland, the Agricultural University of Iceland and the University Centre of the Westfjords. He has also worked as a park ranger almost every summer for the last few years. Guðmundur Ingi was one of the founders of the Icelandic Society for Environmental Scientists. He was the society's first president, in 2007-2010. Guðmundur Ingi served as the Chair of the Fulbright Alumni Association in Iceland in 2017-2018.

Ireland



Mr. Damien English

Minister of Business, Employment and Retail

Damien English TD is the Minister of State for Business, Employment and Retail, having been appointed on July 2nd, 2020. He previously served as Minister of State at the Department of Housing, Planning and Local Government from May 2016 to June 2020. He was first appointed as Minister of State at the Department of Jobs, Enterprise and Innovation and the Department of Education and Skills in July 2014. Minister English's focus in government is on forward-thinking and deliverable initiatives, such as his work on 'Rebuilding Ireland – Action Plan for Housing'; the expansion of the apprenticeship system in Ireland; Project Ireland 2040; 'Innovation 2020' - Ireland's current strategy for research and development, science and technology; 'Housing Options for our Ageing Population' which provides a policy framework to support our ageing population; and the 'National Skills Strategy 2025 – Ireland's Future'. He was elected as a Teachta Dála for Meath West in the general election of February 2020. He secured election at his first attempt to Dáil Éireann in 2002, and at each successive election in 2007, 2011 and 2016. He served as a member of Meath County Council from 1999 to 2004.



Israel



Ms. Tair Ifergan

Director General of Labor, Ministry of Economy and Industry

As of May 2021, Tair Ifergan is the Director General of the Labor Branch in the Ministry of Economy and Industry, following 3 years of service as the Head of the National Institute for Technology and Science, at the Directorate General of Labor. Previously, Ms. Ifergan served in a number of senior positions in the Ministry of Economy and Industry, including as the Senior Advisor to the Director General at the Ministry of Economy and as the Senior Deputy Director General for Human Resources. Ms. Ifergan is an active board member in the Council of Women in Technology and Science at the Ministry of Innovation, Science and Technology and member of the Council of Certified Engineers and Technicians. Ms Ifergan has an MA in Public Policy from Tel-Aviv University and a BA in Political Science and International Relations from The Hebrew University.

Italy



Mr. Andrea Orlando

Minister of Labour and Social Policies

Andrea Orlando was born in La Spezia on February 8th, 1969. He was elected to the Chamber of Deputies, from the 15th in 2006 to the current 18th legislature, and since 27 March 2018 he has been a member of the Parliamentary Group of the Democratic Party. From 22 February 2014 to 1 June 2018, he held the position of Minister of Justice in the Governments chaired by Prime Minister Renzi and Prime Minister Gentiloni. From 28 April 2013 to 22 February 2014, he was appointed as Minister of the Environment and of the protection of the territory and the sea in the government chaired by Prime Minister Letta. At the beginning of 2021 within the new government led by Mario Draghi, Andrea Orlando was chosen to lead the Ministry of Labour.

Mr. Takashi Sakaguchi

Vice-Minister for Policy Coordination, Ministry of Health, Labour and Welfare

Mr. Takashi Sakaguchi has been serving as the Vice-Minister for Policy Coordination in the Ministry of Health, Labour and Welfare since September 2021. His field of responsibility includes the planning and coordination of a wide range of employment and labour policies, such as employment security, labour protection, and equal employment. 

In 2008 he moved back to ELS as the Head of the Employment Analysis and Policy Division and the editor of the Employment Outlook. In 2010, he became the Deputy Director of ELS. He holds a PhD in Economics from the École des Hautes Études en Sciences Sociales (Paris) and a M.Sc. in Economics from the London School of Economics and Political Science. He has published extensively in academic journals and written several books.



Mr. Mark Pearson

Deputy Director for Employment, Labour and Social Affairs

Mark Pearson has been Deputy Director of the Directorate for Employment, Labour and Social Affairs (ELS) at the OECD since 2014. Mr. Pearson works with the Director to provide leadership in the co-ordination and management of the activities of ELS and ensure that it is at the forefront of the international social and employment agenda. Mr. Pearson joined the OECD in 1992, initially working on tax issues. He then moved to ELS, becoming the head of the Social Policy Division from 2000-2008. During this time he initiated work on 'Babies and Bosses', 'Pensions at a Glance' and led the first cross-directorate work on gender, and work on income inequality. In 2009 he became Head of the Health Division where the central focus of work was on how to deliver health care with greater efficiency, including putting much more effort into prevention of obesity and harmful use of alcohol.

Stéphane Carcillo is the Head of the Jobs and Income division in the Directorate for Employment, Labour, and Social Affairs at OECD. He is also a research fellow at IZA Bonn, specialised in labour economics and employment policies. He was previously a senior economist in the Social Policy division where he led the work on youth. He was also an economist in the Fiscal Affairs Department at the IMF, before becoming the labour market advisor to the French Minister for the Economy, Finance and Employment. Head of Division for Skills and Employability

Mark Keese is the Head of the Skills and Employability Division in the Directorate for Employment, Labour and Social Affairs at the OECD. He is responsible for the OECD's work on employment and skill development policies to promote a more inclusive and resilient labour market. He is also closely involved in the work of the G7 and G20 group of economies on employment issues. Mr. Keese has been at the OECD since 1985, covering both macro economic and labour market issues. He was a member of the taskforce that developed the OECD's Jobs Strategy and helped develop the PIAAC survey of adult skills. His published works include articles on labour markets in transition countries, earnings inequality, minimum wages, and ageing and employment policies.
