

PRIVACY POLICY

Startup Inside, a French “Société par Action Simplifiée” incorporated in France with its registered office at 14 RUE DE CASTELLANE, 75008, PARIS, France, registered with the trade and companies register under number 823 904 867 R.C.S. Paris. recognizes data protection as an important topic and understands the responsibility that comes with the handling of personal data. This Privacy Policy describes the privacy practices of Startup Inside related to personal data collected, used, stored and otherwise processed.

WHAT THIS PRIVACY POLICY COVERS

This Privacy Policy applies to the personal data Startup Inside processes as a data controller (i.e. the party that determines what personal data to collect and to what end) in the frame of the “Mobility 4.0 Challenge” organized by the funding members of the Software République and according to the rules of this Challenge.

WHAT PERSONAL DATA IS COLLECTED AND PROCESSED BY STARTUP INSIDE

Personal data means any information relating to an identified or identifiable person. An identifiable person is a person who can be identified, directly or indirectly, in particular by reference to an identification number or to one or more factors specific to the natural person.

For the needs of the “Mobility 4.0 Challenge”, personal data processed by Startup Inside includes:

- Personal information such as first and last name, email address, phone number, job title, company’s name.

In any event, the personal data processed by Startup Inside is limited to data necessary for the purposes described in this Privacy Policy.

WHY YOUR PERSONAL DATA IS PROCESSED BY STARTUP INSIDE

Startup Inside will process your personal data, with your consent, for the following purpose:

- Send you the necessary information for you to take part in the “Mobility 4.0 Challenge”.

HOW LONG YOUR PERSONAL DATA IS RETAINED

Startup Inside does not store your personal data for more time than necessary and only as long as required to fulfill the purposes set out above. Startup Inside will destroy your personal data after December 2022. To determine this appropriate retention period for personal data, Startup Inside considers the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorized use or disclosure of your personal data, the purposes for which Startup Inside processes your personal data and whether Startup Inside can achieve those purposes through other means, and the applicable legal requirements.

WITH WHOM STARTUP INSIDE SHARES YOUR PERSONAL DATA

Startup Inside does not share your personal data.

WHAT ARE YOUR RIGHTS

Depending on the applicable data protection laws, you may have some or all of the following rights with regard to your personal data:

- access your personal data;
- request the rectification, completion, update or erasure of your personal data;
- restrict processing;
- obtain a copy of your personal data stored;
- object to specific processing of your personal data if that processing is based on legitimate interests; and
- data portability.

Moreover, as the processing of your personal data is based on your consent, you have a right to withdraw that consent at any time.
