#### ITMO CARBON CREDITS & CLIMATE PROJECT DEVELOPMENT Supporting Ghana's socioeconomic development & climate impact targets through the 'Transformative Cookstove Activity in Rural Ghana' project

#### WHAT WE DID:

Supported Ghana's socioeconomic development and climate impact targets through the 'Transformative Cookstove Activity in Rural Ghana' project – a pioneering ITMO project certified under Article 6.2 of the Paris Agreement.

#### WHO WE DID IT FOR:

Approximately 968,000 Ghanaian citizens, particularly smallholder farmers in rural and peri-urban areas.

#### HOW WE DID IT:

In partnership with Envirofit and the KliK Foundation, ACT Group facilitated the distribution of 180,000 locally produced Improved Cookstoves (ICS). These cookstoves are designed to reduce smoke and toxic emissions by up to 80%, enhancing household air quality and reducing firewood consumption.

#### THE IMPACT:

- Reduction of ~2.25 million tCO₂e annually over eight years, totalling an estimated 18 million tCO<sub>2</sub>e over the project's lifetime
- Creation of nearly 300 jobs across the value chain, fostering economic growth and improving livelihoods
- Significant health improvements for ~968,000 locals due to decreased indoor air pollution

#### CLIMATE PROJECT DEVELOPMENT

#### Providing an integrity-focused investment opportunity to our clients while supporting a sustainable economy and preserving the Amazon

#### WHAT WE DID:

Provide a sustainable investment opportunity while preserving the Amazon ecosystem.

#### WHO WE DID IT FOR:

Local communities in the Colombian Amazon.

#### HOW WE DID IT:

Launched the pilot phase of the Amazon Nativa Project, transforming 550 hectares of previously deforested land into sustainable timber and açai berry farms. This initiative is supported by financing from thought-leading partners, promoting sustainable agricultural practices and aiding in the recovery of the local ecosystem.

#### THE IMPACT:

- Afforestation of 550 ha with 600,000 trees planted
- Estimated removal of 250,000 tons of CO<sub>2</sub>e from the atmosphere

**Improving Energy Efficiency** for St. Louis Hospital in Paris, France

#### WHAT WE DID:

Improve energy efficiency

#### WHO WE DID IT FOR:

St. Louis Hospital

#### HOW WE DID IT:

In collaboration with our technical partner Proxiso, we improved the outdated infrastructure of the hospital, focusing on the insulation of parking floors, heating and domestic hot water (DHW) networks over 80,000 sqm of area covered and over 20 km of heating and sanitary hot water networks.

#### THE IMPACT:

- 13% reduction in GHG emissions
- Energy savings: 200,000 EUR per year an 8-10% reduction compared to pre-project costs, all project costs subsidized through the sale of the CEE Certificates the project created under France's national system, improved comfort of the hospital's users, professional teams, and occupants
