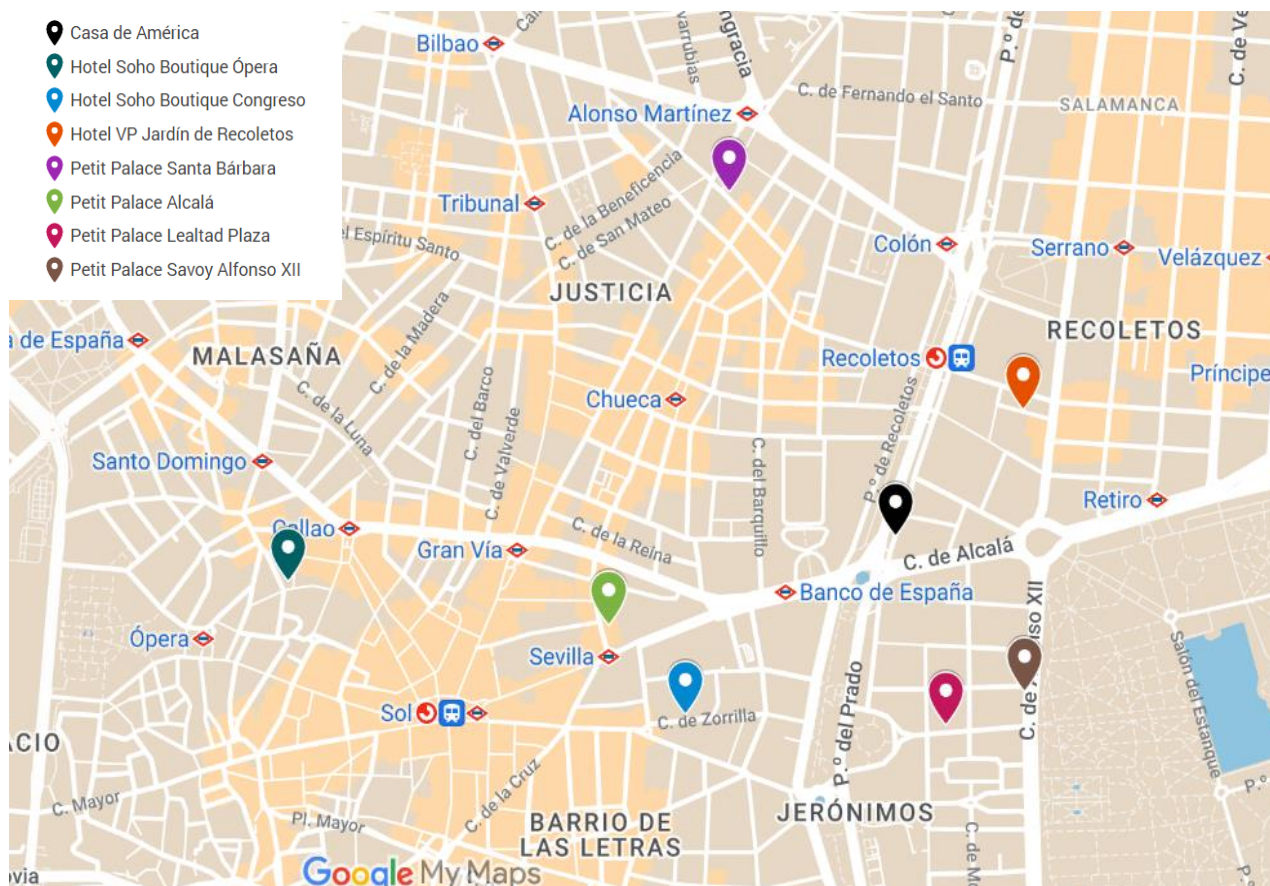

3. TRANSPORTATION

There are various options to get to Casa de América from different points of the city:

🚌 Buses: 1, 2, 5, 9, 10, 14, 15, 20, 27, 34, 37, 45, 51, 52, 53, 74, 146, 150, 202.

🚇 Metro: Line 2 (Bank of Spain)

🚆 Railway: Recoletos Station

P Parking: Paseo de Recoletos

✈ Airport transportation: You can find below a list of public transport options to get from the airport Madrid-Barajas to Casa de América. For more information, please check the [Airport Madrid-Barajas website](#).

RENFE railway company C1 or C10 (30')

- Airport - Recoletos station (6 minutes walking to Casa de América).
- Single ticket tariff: 2.60€.
- Schedule: The first train to Madrid (Príncipe Pío) leaves at 5.56 hours, and the last at 22.25 hours.

Bus 203-Exprés (35-40')

- Stop in Cibeles (Casa de América) – Madrid city center.
- Price: 5€.
- Schedule: every 15-20 minutes during daytime service (from 6:00 to 23:30) and every 35 minutes during night-time service (from 23:30 to 6:00 – called N27 Exprés Airport).

Line 8 Metro Airport (35-40')

- L8 metro Airport – Nuevos Ministerios.
- Switch to train C7 (or C1, C2, C10): Nuevos Ministerios - Recoletos (6 minutes walking to Casa de América).
- Price: single ticket (1.5-2€) + extra airport (3€).
- Schedule: From 6.05 a.m. (morning) to 1.30 a.m. (night).

Bus 200 (45-50')

- Bus 200: From Airport to Avenida de América.
- Switch to Bus 52: From Príncipe de Vergara-María Molina to Cibeles.
- Price single bus ticket: 1.50€.
- Schedule: Opening hours from 5.00 to 23.30 with buses every 10-20 minutes.

Taxi/carsharing services (20')

Current COVID-19 regulations

Please note that the information below is correct at the time of circulation. Details and protocols are subject to change according to the evolution of the health situation.

According to the [current COVID-19 measures in the Community of Madrid of Spain](#), the access to the conference venue is no longer subject to sanitary pass and wearing a mask onsite is not obligatory.

General recommendations from the Spanish Government are to keep social distance of 1.5 metres when possible, having an adequate ventilation of closed spaces with great affluence of people and ensuring constant disinfection and cleaning of surfaces in public spaces.

Safety measures on-site

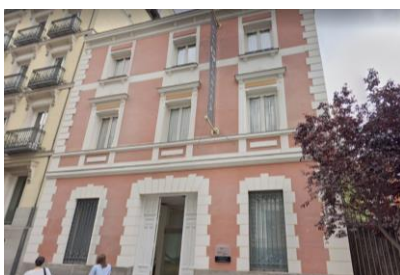
The event will be in-person respecting all COVID-19-related health guidelines by the Spanish authorities. Hand-gel dispensers will be available around the Conference Centre and delegates are recommended to maintain safe physical distance and consider wearing a face mask.

If at any stage delegates show COVID-19 symptoms we ask that they do not access the site and inform the OECD Secretariat. In addition, if any delegates test positive for COVID-19 during the conference we ask that they inform the Secretariat immediately so that we can activate the necessary measures.

5. SECURITY AND ACCESS

An internal security zone around the High-Level Forum venue will be established. Security services will be present throughout the site and will carry out general surveillance of all conference rooms and public areas.

We invite participants to access the venue via the entrance in Calle Marqués del Duero shown in Annex Error! Reference source not found.. This entrance is restricted to the Forum participants and press. Please note that there will be no access via the main entrance to the building on the Plaza de Cibeles. 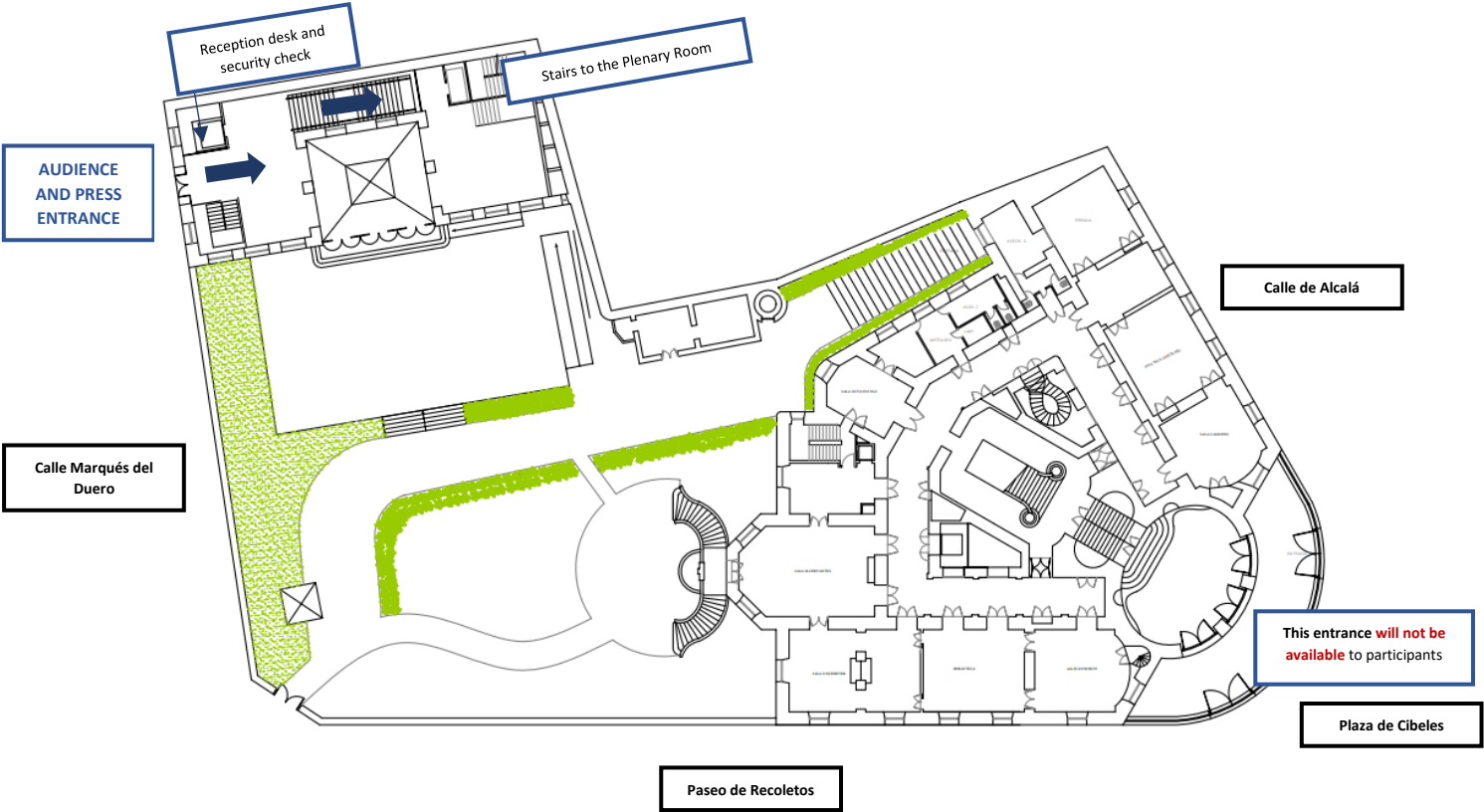

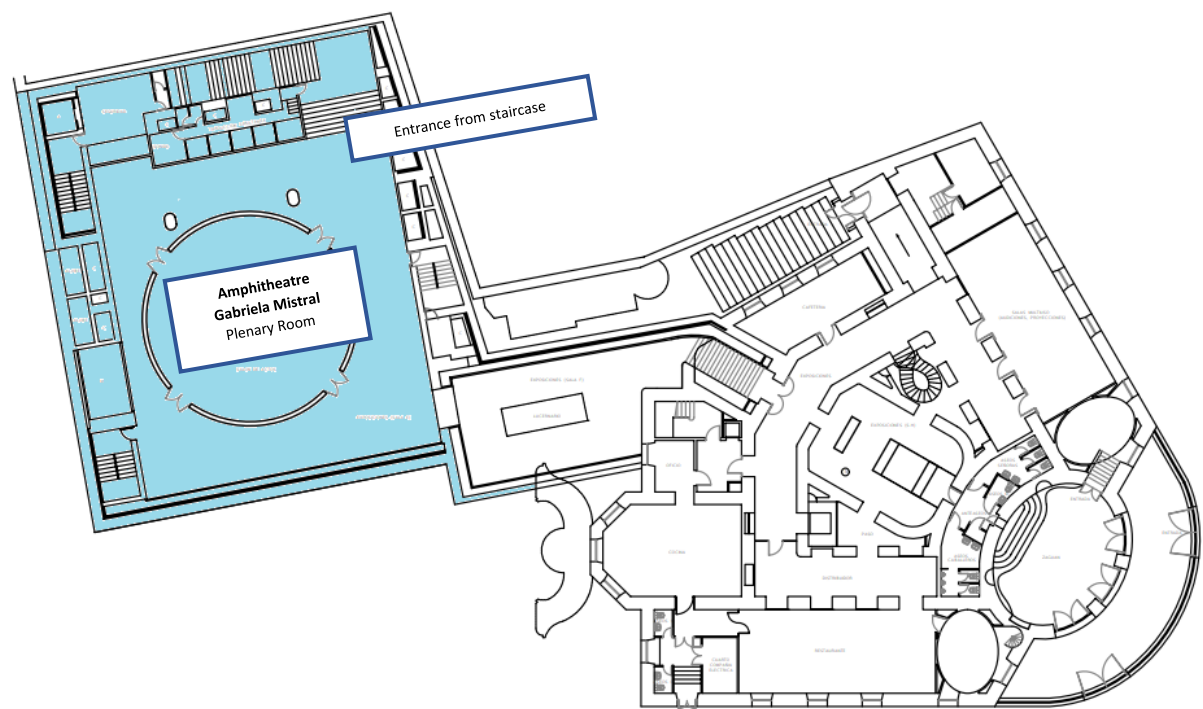
