Compliant with the Union Customs Code, **CUSTOMS via conex™** provides you with all the guarantees of security and traceability required for Authorised Economic Operator status.



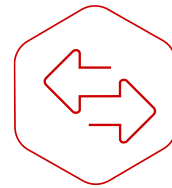

Export Control System for the electronic monitoring of proof of exit before leaving European customs territory.

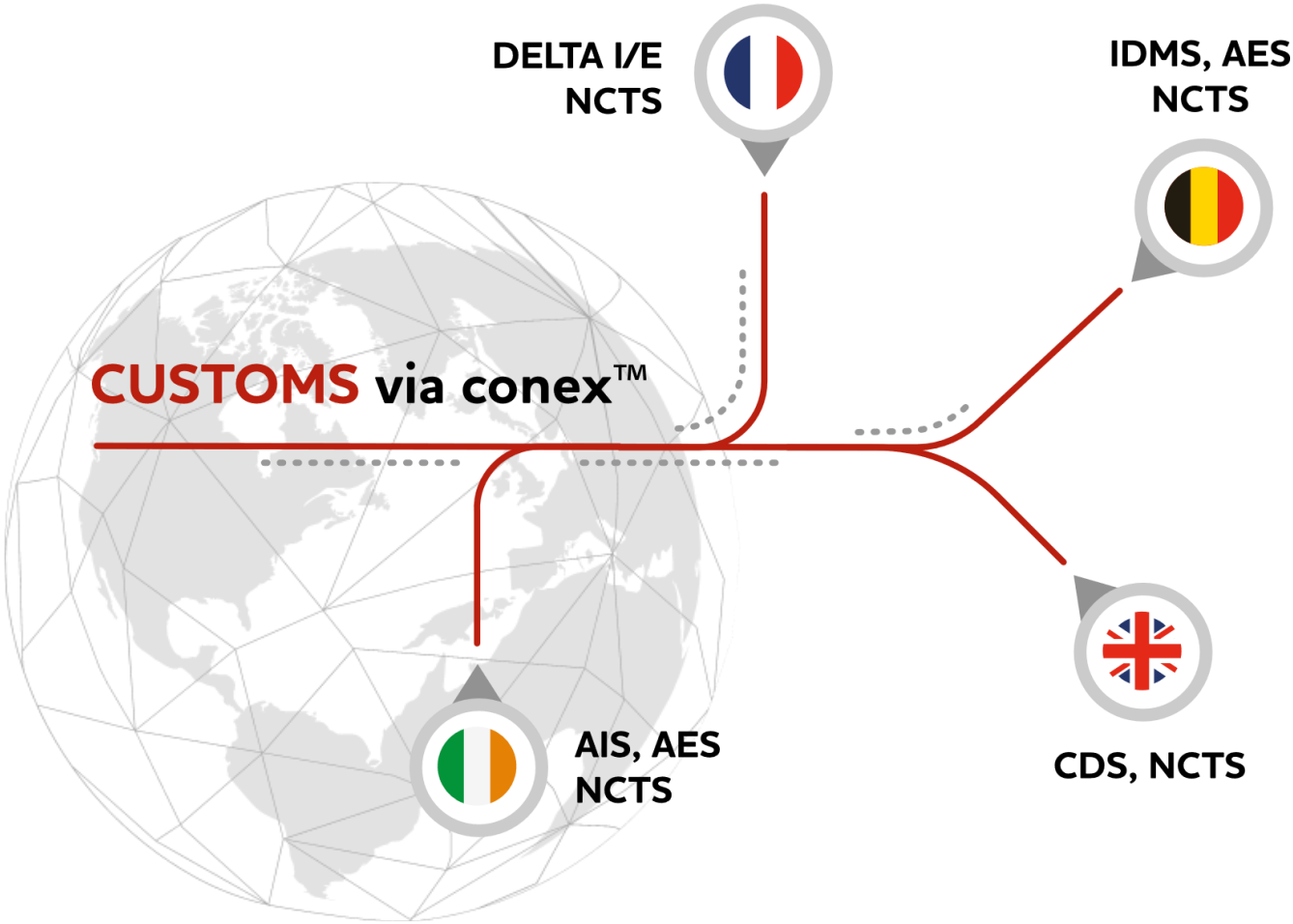

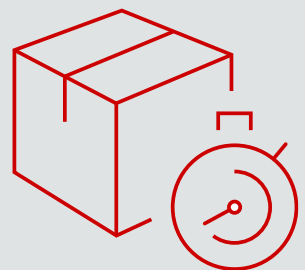
Automatic insertion of customs tariff data

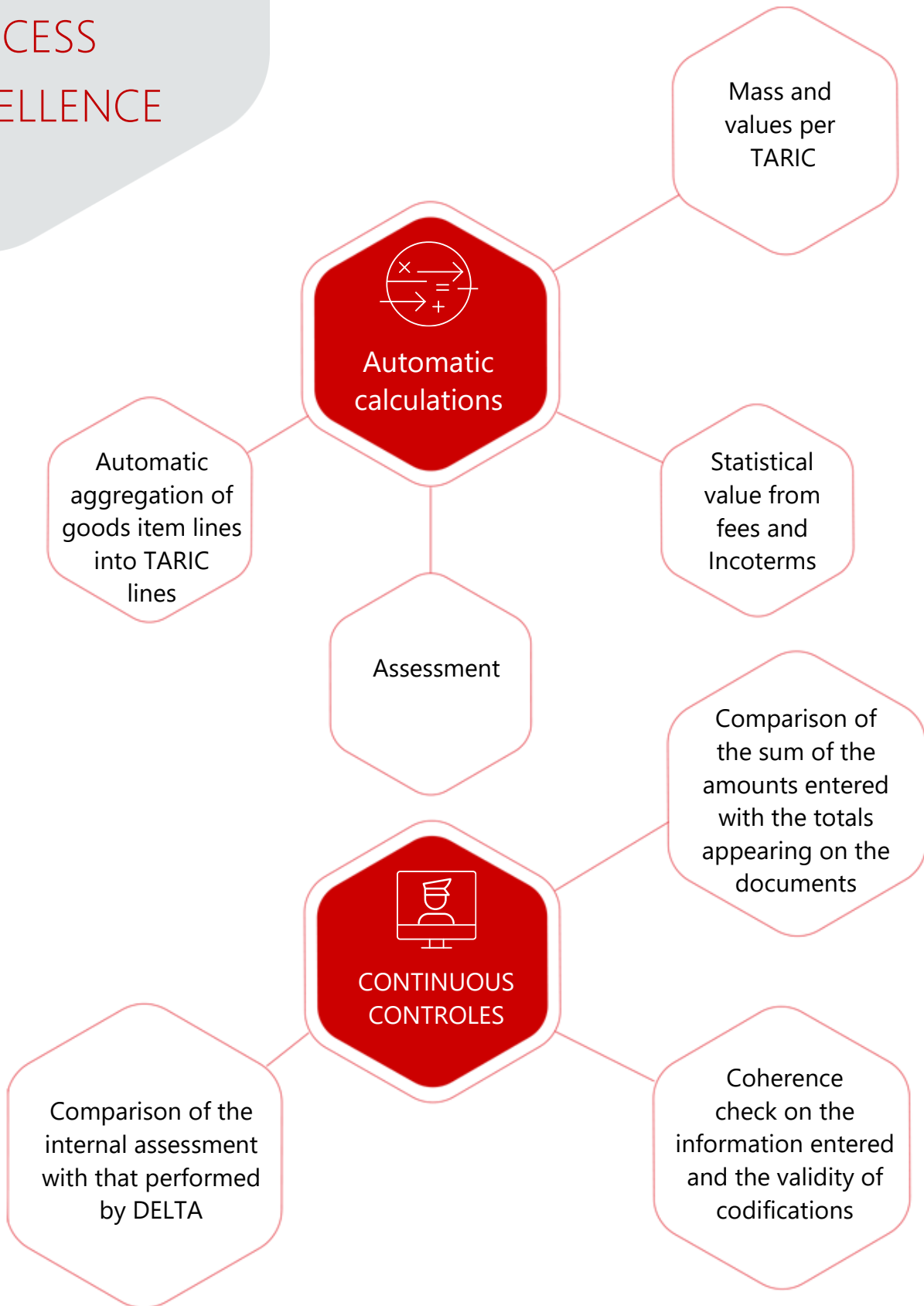

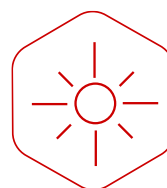
