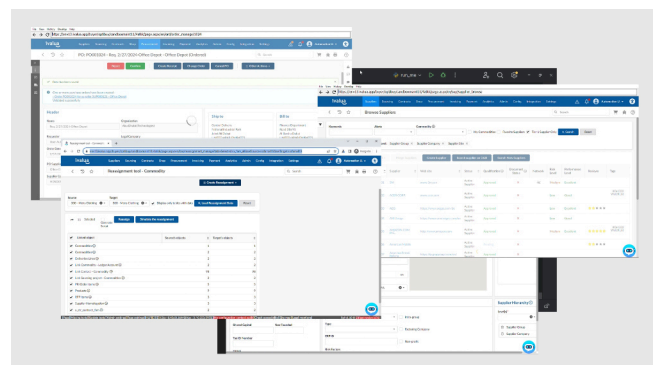
### STEP 1 - CREATE TEST SCENARIOS

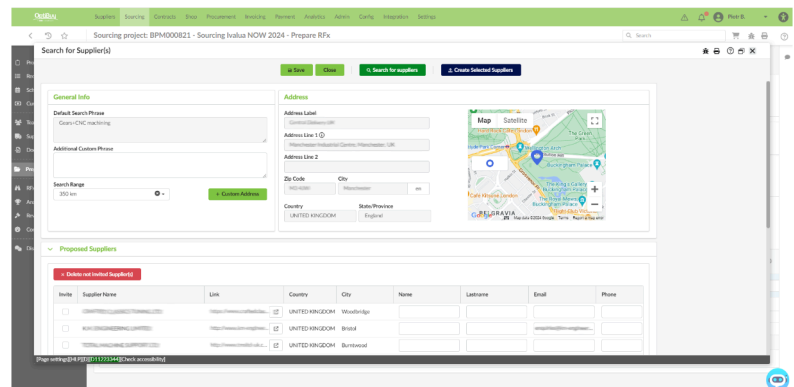

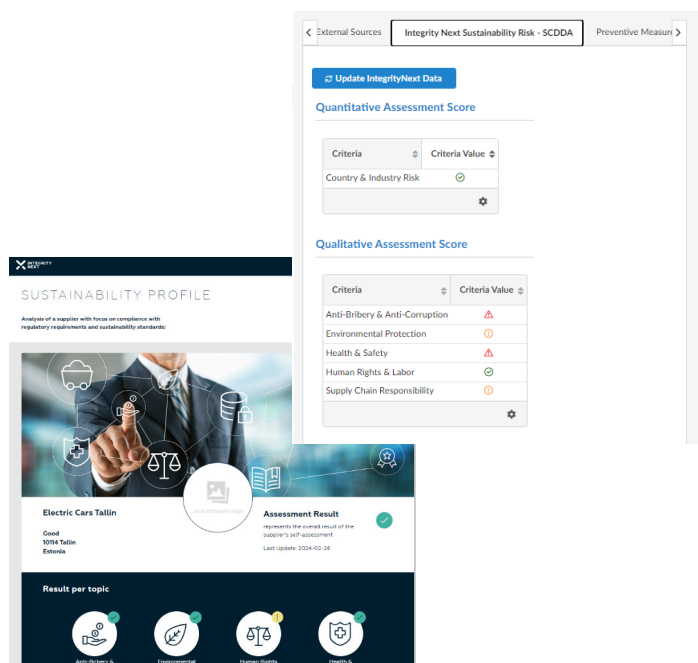
