- > The DSP is your secure personal Electronic Health Record, which is under your direct control.
- > It holds your key health information that has been uploaded by the healthcare providers involved in your medical care.
- > It gives at all times a snapshot of your health history. This helps the healthcare providers to provide you with the best possible treatment and care, and facilitates their medical follow-up and care coordination.
- > It contributes to an optimal and coordinated medical care, at the benefit of your health.
- > It is financed by Luxembourg government, and has a solid legal base.



AGENCE eSANTÉ :

- > is tasked to guarantee a high security level.
- > is liable for the security and data protection of the health information stored in your DSP.
- > sees to it that the required safeguards are in place so as to ensure the highest possible level of security and data protection.

YOUR DSP

Get involved in your healthcare, and become an active partner of your healthcare team



- > does not replace existing medical health records held by your healthcare providers; they will continue to update these with the latest information and will only upload the relevant health information into your DSP.
- > will be supplied with health information over time once your DSP has been activated according to the instructions described in the DSP-activation letter you receive from Agence eSanté.

ONLINE ACCESS TO YOUR DSP:

- > is possible via our web portal www.esante.lu, by means of your personal secure access code which you receive from Agence eSanté by mail.
- > is limited to yourself and the healthcare providers registered in Luxembourg who are involved in your medical care and whom you have granted access.
- > is logged, so that you can see at any time who has accessed your DSP, when and why
- > can be assigned to a "DSP-assistant" i.e. a person you grant a right of access so as to help you manage your DSP.

YOUR RIGHTS WITH REGARD TO YOUR DSP:

- > you can view the health data stored in your DSP
- > you decide who can access your DSP
- > you can define the confidentiality level of certain data
- > you can add health related data and documents in your personal area
- > you can request your DSP to be closed - and re-opened - at any time
