PEEL-OFF TECHNOLOGY:

Peel-off masks are skin care products that have been included in professional skin care routines for many years. These powder products are made of alginate and require a mixing step with water before being applied to the skin. A natural alginate complexation reaction consequently occurs, turning powder into a soft mask. Peel-off masks perfectly shape facial or body contours, helping active ingredients to penetrate the skin. Once dry, this second skin can be removed in one piece and does not need to be washed off.

COMPOSITION & PROPERTIES:

TURMERIC DRY EXTRACT

Turmeric is a herbaceous plant native to southern Asia. Once dried, it is reduced to powder to obtain the spice of the same name very popular in the kitchen. We have selected a high quality extract from French organic agriculture. This dry extract of turmeric is of high quality because of its French origin, it comes from organic farming. Used in cosmetics turmeric is well-known for its exceptional antioxidant properties ; it delays the process of ageing by helping cell growth and renovation. But this spice is also a precious ally for people suffering from acne thanks to the amount of curcumin (an active substance) contained in turmeric which also has anti-inflammatory and antibacterial properties[1].



GOJI BERRY POWDER

This organic extract of Goji berry in fine powder form is obtained by spray drying process of fresh berries. Goji berries, the secret of youth in Tibet, have long been used by Chinese herbalists and traditional Tibetan pharmacopoeias. The small red berries of goji are rich in many active ingredients but especially contains 400 times more vitamin C than orange. Our skin benefits from the richness of vitamins, carotenes and flavonoids of goji berries to protect themselves from free radicals[2]. They work by activating the immune system of cells and repairing the damage caused by stress and aging.

PROTOCOL:

Face: 20 g of powder + 50 ml of water **

Face and neck: 30 g of powder + 70 ml of water **

Room temperature or warm water

- 1 Pour water on the powder and mix for 1 minute.
- 2 Apply immediately in a semi-thick layer with a spatula or a cosmetic brush.
- 3 Leave on for 20 minutes then remove the mask in one piece.

Refine the removing of the mask with a damp sponge.
